• The Center for Chicano Studies is pleased to issue a call for proposals from **graduate students** engaged in research on topics pertaining to Chicana/o or Latina/o populations in the United States. Projects

grounded in all academic fields are welcome with priority given to interdisciplinary research projects and to applicants not previously funded by the Center.

The selection committee will be awarding grants of up to \$2,000 each for 2006-07. Interested UCSB graduate students should submit five copies of the application form (available at the Center, SH 4518) and a 5-page narrative that includes: a project abstract (150 words), a description of the research (including a brief review of pertinent literature), a description of methodology, the significance of the research, and a detailed budget. Funding can be used for supplies and other costs associated with research (e.g., interview transcribing, research travel, travel to libraries or to meet with collaborators). Applicants must also submit a current vitae and a letter of support from a faculty advisor.

Proposals will be evaluated by a selection committee appointed by the Advisory Committee of the Center for Chicano Studies. In addition to such standard review criteria as clarity, quality and feasibility of the proposal, the review committee will assign special importance to the research methodology articulated. Projects contributing to an established, or proposed, MA thesis or Ph.D. dissertation will also receive preference. At the beginning of Fall quarter 2007, applicants awarded funding will be expected to write a brief report of their expenditures. Applicants will also be invited to present their research at a colloquium to be held in Fall 2007.

Completed applications must be received by the Center for Chicano Studies (South Hall 4518) by 4:00 pm on Monday, **October 16, 2006**. These awards are made possible through support provided by the UC Committee on Chicano/Latino Research.

- The Center for Chicano Studies invites proposals for the creation of research working groups in any area of Chicana/o Studies. Proposed working groups **should include three or more faculty**, and proposals drawing together faculty from different fields of training are encouraged. Successful proposals will receive seed funding for a three-year period. Upon conclusion of the three-year term, working groups may reapply for funds. Proposals will be judged according to a variety of criteria. Heavily weighted among these criteria will be the prospect of receiving extramural funding. Applicants should identify specific funding agencies that will be targeted by the working group, and, if possible, specific grant competitions or funding opportunities that will be pursued. It is anticipated that each working group will receive approximately \$15,000 per year as seed funding. Proposals should include budgets indicating how these funds would be used over the three-year period. In addition to the high priority given to the promise of extramural grant success, the proposal review committee will focus on the following criteria:
  - the significant incorporation of graduate and/or undergraduate research assistants;
  - the development of innovative research that contributes to the field:
  - the pursuit of research that has important policy implications (direct and/or indirect);
  - a design that promotes mentoring among faculty and students;
  - the effective use of resources at UC Santa Barbara (including archives, research tools, special collaborators);

Proposals should include the following: an application cover sheet; a narrative of no more than ten pages; a tentative budget for the three-year period; a short (two-page) c.v. for each faculty participant. The narrative section should include the following: 1) a brief literature review for the area to be addressed by the working group; 2) a description of the research to be pursued, including a summary of the methodological issues to be

engaged; 3) a statement regarding the significance of the research in the context of the field as a whole; 4) a tentative schedule of activities to be pursued over the three years; 5) a plan for pursuing extramural funding. Award recipients must submit annual reports to remain eligible for continued funding. Allowable expenses include: research assistance; lab analyses; computing assistance; research expenses and supplies; domestic and international travel for data collection, field work, archival research, and laboratory work. Items that will not be funded include: travel to conferences; salary payments to Principal Investigators or other academic salaries (except student research assistants); equipment purchases, including computers and computing accessories/parts. All budgets are subject to detailed administrative review by the center.

The proposal review committee will be selected by the center's advisory committee, and will be staffed by UC faculty who are familiar with the center, and who have expertise in the areas addressed by the proposals. Application forms will be available at the center (South Hall 4518).

The proposals should be delivered to Theresa Pena at the center by **4:00PM**, **October 23**, **2006**. No electronic, fax or late submissions will be accepted.
